Under the Drug Supply Chain Security Act (DSCSA), under specific circumstances wholesale distributors

and others in the life sciences supply chain are required to verify the product identifiers on packages and cases. This includes the US National Drug Code (NDC), serial number, LOT, and expiration.

Knipper VRS verification router service is an interoperable solution developed based on a standard established by the Healthcare Distribution Alliance (HDA) and US life sciences industry stakeholders. It is used to manage the acceptance, formatting, and delivery of requests and responses to support DSCSA verification requirements and other business requirements as defined between trading partners. Industry stakeholders have publicly estimated over 80,000,000 drug products are returned per year and resold by wholesalers – and each would be potentially subject to verification under the DSCSA.

When a return occurs, and if the item will be returned to stock for future sale, the recipient scans the DSCSA required Data Matrix symbol on packages or barcodes on cases. The recipient's VRS system routes the verification request through the VRS network. When Knipper 3PL is acting on behalf of a manufacturer, the Knipper VRS service will process their required DSCSA verifications. If the verification is successful, the recipient's VRS is notified. If the request is unsuccessful, it may indicate there is a suspect product and both Knipper 3PL and the recipient are made aware of the situation.
