A global pharmaceutical leader calls on Knipper 3PL to flawlessly execute the relocation of sample and promotional storage and pick/pack operations of a recently acquired company to Knipper facilities.



THE SITUATION

Following a corporate business acquisition by a leading pharmaceutical company, a decision was made to shut down the acquired internal distribution facility and relocate all of its sample and promotional storage and pick/pack operations to Knipper facilities. Sample Accountability (SA) operations were also to be transferred to Knipper.



THE CHALLENGES

Successfully transferring more than 4,500 pallets, including 700+ individual SKUs (literature and samples combined) as well as implementing and ensuring that all data feeds were developed, tested, and validated prior to the movement of product between facilitates.



THE KNIPPER 3PL SOLUTION

- A cross-functional team including Sales Operations, Logistics/Warehousing, Sample Accountability, Compliance, Information Technology, Sales and Marketing, and Project Management was assembled and met weekly.
- An inventory report-and-cleanse was performed, and a warehousing set-up to accommodate transfer of products was completed prior to receipt of all transferred items, including those that required special handling, such as Cold Chain Storage, DEA Storage, and others.
- With a rolling cutover period based on physical inventory audits being conducted, Knipper supported the push/pull of data to multiple Veeva orgs and data coming back a singular SIMs system and data being pushed from a

singular Warehouse Management System.

THE RESULTS

Support for 3000+ sales representatives during the transfer included the establishment of a defined ordering process and recommended post-transition initial "Push Shipment."
